SYSTEM COMMENCEMENT REVIEW

- April 7, 2022: Chair Dorn Smith asks System Leadership Council to "begin an immediate assessment of USC System policies and practices regarding commencement exercises, toward recommendations for potential revisions to those policies and practices."
- June 24, 2022: Presentation to System Committee
- August 10, 2022: System Leadership Council Discussion



KEY CONSIDERATIONS

- Student and family-focused commencements.
- Promoting celebratory atmosphere at students' home institutions.
- Creating traditions and connections that promote alumni engagement and pride.
- Logistical challenges of conducting and attending multiple ceremonies across the state.
- Accommodating growing numbers of graduates while maintaining individual recognition.



RECOMMENDATIONS FOR CONSIDERATION

- Modify current policy to allow system institutions to schedule and conduct ceremonies in a way that best serves students and families.
- Permit comprehensive universities to hold December commencement exercises on their campuses.
- Authorize system chancellors to confer degrees at their universities' and Palmetto College regional campuses' commencement exercises.
- Designate VP for System Affairs to serve as liaison between comprehensive universities and Palmetto College regional campuses and the President/BOT for commencement planning/coordination.



POTENTIAL NEXT STEPS

- Present revised BTRU 2.00 for review in accordance with committee discussions.
- Upon approval, modify related policies as warranted.
- Develop and implement procedures for commencements in accordance with revised policies.

SUMMARY OF SHARED SERVICES

- 2018 Huron Consulting engaged to review system support services.
- Using a comprehensive list of operating units identified as part of the engagement, Huron worked with system stakeholders to identify those units providing system-wide services.
- Activity-level metrics used to determine proportion of services allocated to Columbia and other system institutions.
- The proportions referenced above were further refined using survey-derived qualitative considerations.
- The analysis resulted in the breakdown set forth on the following slide.
